DOCUMENTS REQUIRED

- **RIDERS**

A Rider's form must be filled in by each rider indicating the following **obligatory** information:

- Name and Surname
- Nationality
- Place and Date of Birth
- Country of Residence
- Contact details (telephone, fax, mobile no. and email)

The authorisation (signed and stamped on headed paper) must be sent from the rider's National Federation to the following fax number: **0039 06 83668482** or email: **e.pepe@fise.it** . This authorisation must indicate the following **additional obligatory** information:

- Discipline and/or disciplines
- Licence equivalent in Italy - for example: Brevetto, 1° Grado, 2° Grado Completo, 2° Grado Qualificato Completo (please consult the below tables)

- **HORSES**

All horses competing in Italy must have a certified national or international passport with a recognition card and all vaccinations up to date in accordance with Italian Veterinary Regulations.

Declaration (please see attached form) indicating the horses details, qualifications and the level in which it is authorised to compete (for example Novice, Intermediate and Advanced).

This form must be completed in its entirety.
